## **Homeowner Association Candidate Certification Form**

In accordance with section 720.3033(1)(a) of Chapter 720, Florida Statues, within 90 days after being elected or appointed to the board of an association, each newly elected or appointed director shall certify in writing to the secretary of the association that:

- A. He or she has read:
  - 1. the association's declaration of covenants,
  - 2. Articles of Incorporation,
  - 3. Bylaws,
  - 4. Current written rules and policies.
- B. He or she will work to uphold such documents and policies to the best of his or her ability;
- C. He or she will faithfully discharge his or her fiduciary responsibility to the association's members.

In lieu of such certification, within 90 days after being elected or appointed to the board, the newly elected or appointed director may submit a certificate of having satisfactorily completed the educational curriculum administered by a division-approved education provider within 1 year before or 90 days after the date of election or appointment.

The written certification or educational certificate is valid for the uninterrupted tenure of the director on the board. A director who does not timely file the written certification or educational certificate shall be suspended from the board until he or she complies with the requirement. The board may temporarily fill the vacancy during the period of suspension.

The secretary shall cause the association to retain a director's written certification or educational certificate for inspection by the members for 5 years after a director's election or the duration of the director's uninterrupted tenure, whichever is longer. Failure to have such written certification or educational certificate on file does not affect the validity of any board action.
